- 3.0 The license is valid for a period of 5 years, renewed every year

- 4.0 This license is based on information provided in the Septage Collection and Transportation License Application.
- 5.0 It may be noted that undertaking this task without a valid license will be punishable under the law.
- 6.0 Any unauthorised change in personnel, equipment or working conditions as mentioned in the application by the person licensed shall constitute a breach of license.
- 7.0 It is the responsibility of the licensee to take prior permission from the prescribed authority to stop the activity as permitted in this license.
- 8.0 The licensee shall comply the conditions stipulated in the attached Annexure I.
- 9.0 License is liable to be cancelled in case of violation of any Acts, Rules, Regulation, guidelines relating to the operation of Septage system or in case of safety protocols not being adhered to or in case of non-permitted disposals.
- 10.0 The license may be suspended or revoked for condition of non-compliance and is not transferable. Copy of the license shall be carried in every registered vehicle used by the licensee.

Annexure-I

Conditions for license for collection, transportation and disposal of septage

- 1.0 The authorized license shall comply with "Operative Guidelines on Septage Management (Collection, Transportation Treatment and Disposal) in Greater Warangal Municipal Corporation (GWMC) - 2016" and the amendments made there under from time to time.
- 2.0 The License should handle the waste without any adverse effects to human health and the environment.
- 3.0 Shall attend the request received from the citizen for desludging within 24 hrs.
- 4.0 The vehicle should have a valid permit from the transport department to operate in Warangal and also valid "Pollution Under Control" certificate. The licensee shall comply all the relevant provisions of motor vehicles act, 1988 or Rules there under
- 5.0 The vehicle should have valid fitness certificate.
- 6.0 The septage vehicles shall be fitted with Global Position System (GPS) and the details of GPS shall be shared with GWMC for monitoring purpose.
- 7.0 The septage shall be transported only in the vehicles approved for this purposes by officer authorized for this purpose by the commissioner.
- 8.0 The vehicle shall be painted with Yellow colour duly marked with in Red Colour "SEPTIC TANK WASTE"
- 9.0 The entire operation of desludging, transportation and disposal shall be carried out only from 07.00 am to 07.00 pm on all days
- 10.0 Should own leak-proof, odour and spill proof transporting vehicle(s) with a proper vacuum/suction and discharging arrangement.
- 11.0 The operator, drivers and workers shall have adequate training in septage desludging and transportation.
- 12.0 Shall have trained workers equipped with uniforms, safety gadgets, tools and vacuum trucks as defined in the Manual Scavenging Act 2013.
- 13.0 Shall be responsible for taking all the safety measures including provision of hand held gas detectors, rubber boot, face mask, eye protection, gas masks, protective gear, oxygen mask with oxygen cylinder and first aid box etc. and such other measures as prescribed by the officer authorized by GWMC for grant of license for the safe operation of the people deployed.
- 14.0 Shall adopt approved standards and procedures for desludging and pumping. The cleaning of the trucks shall be under taken at the designed areas only.

- 15.0 After each desludging operation, the area shall be properly cleaned and disinfected with relevant cleaning agents such as bleaching powder and lime.
- 16.0 After desludging, workers should follow proper hygiene practices such as washing hands with soap.
- 17.0 In the event of accidental spillage of sludge/septage, the operator shall immediately take action to contain the sludge/septage, minimize the environmental impact, and begin clean-up procedures, and inform immediately over phone to municipal health officer and subsequently submit a report within 24 hrs.(as per the enclosed Form I).
- 18.0 The staff deployed by the licensee shall be insured for any accident during the process of cleaning, transportation and disposal of septage
- 19.0 The licensee shall be responsible for ensuring that every person deployed undergoes health check-up at least once in every year and submit record of the same to MHO, GWMC.
- 20.0 The licensee shall be fully and completely liable for any damage to any person, vehicles, property and environment in case of any accident or disaster.
- 21.0 Shall not charge any amount from the owner/occupier of the building in excess of the prescribed fee, as and when notified by Commissioner, GWMC from time to time.
- 22.0 The licensee shall display socially relevant messages on the truck as per the request of GWMC and per feasibility.
- 23.0 Penalties will be imposed on the licensee in case of not complying with the terms and conditions of this order and / or GWMC will initiate appropriate action too.
- 24.0 Shall follow the manifest system (movement document) for transporting septage within GWMC in the attached format (Form II) and also entry the details in the prescribed mobile app. The mobile app to the licensee is being given by GWMC .
- 25.0 Shall submit monthly consolidated report to Municipal Health Officer in the attached format (Form III).
- 26.0 Penalties will be imposed on the licensee in case of not complying with the terms and conditions of this order and / or GWMC will initiate appropriate action too.
- 27.0 In case of violation of any of the provisions of these regulations the license shall be liable to be cancelled, security of the licensee shall be forfeited and he shall also be liable to pay penalty as prescribed for violation of these regulations.
